Your offer of admission is contingent upon completing Parts A and B by the dates indicated below.

PART A: DGSOM uses the AMCAS Choose Your Medical School (CYMS) Tool to build a class of outstanding physician trainees.

- 1. The AMCAS Choose Your Medical School (CYMS) Tool is not active until **February 19**, **2026**. Your acceptance will be held until February 19, 2026.
- 2. Starting February 19, 2026, to continue to hold your acceptance at DGSOM, please indicate your intention to enroll with DGSOM in the AMCAS Choose Your Medical School (CYMS) Tool.
- 3. In fairness to other applicants, if you have made a final decision not to attend DGSOM, **promptly** withdraw your application from DGSOM (as per <u>AMCAS Application and Acceptance Protocols</u>).
- 4. On or before April 15, 2026, narrow your selection(s) of medical schools to no more than three schools or programs, and withdraw your acceptance(s) from all other schools or programs via the AMCAS CYMS tool (as per <u>AMCAS Application and Acceptance Protocols</u>).
- 5. On or before April 30, 2026, choose the school or program to which you plan to matriculate and promptly withdraw your acceptances from all other schools or programs via the AMCAS CYMS tool (as per <u>AMCAS Application and Acceptance Protocols</u>). After April 30, 2026, your offer of acceptance will expire after **2 business days** if you have not indicated on the CYMS tool "Plan to Enroll" with DGSOM or have made "No Decision" on the CYMS tool regarding the DGSOM offer of admission.
- 6. For offers made on or after April 30, 2026, you will have **5 business days** to indicate your intention to enroll with DGSOM via the "**Plan to Enroll**" option in the AMCAS CYMS tool. After **5 business days**, offers will expire for applicants who have not indicated on the CYMS tool "**Plan to Enroll**" with **DGSOM** or have made "**No Decision**" on the CYMS tool regarding the DGSOM offer of admission.

7. Commit to Enroll:

1. For those accepted to the Traditional MD or Prime-LA Tracks at DGSOM, by June 1, 2026 at 3:00pm Pacific Time, indicate your intent to matriculate with

DGSOM by selecting "Commit to Enroll" with DGSOM using the AMCAS CYMS tool. CYMS may experience delays when recording updates. To avoid missing the CTE deadline and risking your seat in the class, please allow extra time for your final decision to be processed. Should you choose not to select "Commit to Enroll" with DGSOM on the CYMS tool, your offer of admission to DGSOM will expire.

- 2. For those accepted to the MSTP Track at DGSOM, by May 8, 2026 at 5:00pm Pacific Time, indicate your intent to matriculate with DGSOM by selecting "Commit to Enroll" with DGSOM using the AMCAS CYMS tool. To avoid missing the CTE deadline and risking your seat in the class, please allow extra time for your final decision to be processed. Should you choose not to select "Commit to Enroll" with DGSOM on the CYMS tool, your offer of admission to the MSTP Track at DGSOM will expire.
- 8. For those accepted after June 1, 2026, you will have 5 business days to make a decision.
- 9. Declining or withdrawing an offer at any time in the Applicant Portal is final and cannot be reversed.

PART B: Complete these additional contingencies to hold your seat in the DGSOM class.

- 1. Successful completion of your academic work required for admission.
- 2. A final transcript and Bachelor's degree granted. If your Bachelor's degree was conferred after May 2026, you will be contacted for further instructions to submit your final transcript with degree conferral.
- 3. Completion of a health exam and all compliance requirements, including the Technical Standards.
- 4. Criminal background clearance is required. You will receive information to complete this process via AMCAS beginning January, 2026.

Following your acceptance of our offer of admission, you will receive instructions via the <u>Applicant Portal</u> to complete the Financial Aid Institutional Application and to complete the FAFSA (available at <u>studentaid.gov</u> from October 1, 2025 onward). Once you submit these completed applications, you will receive your Preliminary Award from DGSOM via the Bruin Financial Aid portal detailing your financial aid award package. Scholarship awards will be issued in the coming months and, should you receive a scholarship, you will be notified promptly, and this update will be reflected in your Bruin Financial Aid portal.
